Swimmers may enter up to <u> 4 </u> events/day, exclusive of relays. Teams may enter <u> </u> relays per relay event. Swimmers may compete in <u> 1 </u> relays/day. <input type="checkbox"/> The Meet Director reserves the right to limit entries, if necessary, to manage the timeline and number of competitors and spectators at each session.
Entry Eligibility	<input type="checkbox"/> Swimmers must be current athlete members of a YMCA swim team. Coaches must be current coach members of YMCA Swimming and must check in on each day of the meet.
